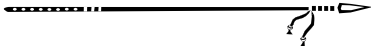

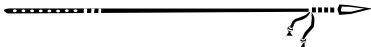

STATEMENT OF AGREEMENT*

THIS LETTER OF AGREEMENT BETWEEN _____ (HEREAFTER REFERRED TO AS THE ATHLETE) AND THE HEADHUNTER CLUB COVERS THE PERIOD FROM THE DATE OF SIGNATURE THROUGH JANUARY 1st, 2011.

I WOULD LIKE TO JOIN THE HEADHUNTER CLUB.

THE ATHLETE AGREES TO THE FOLLOWING:

THE ATHLETE WILL WEAR CLOTHING DISPLAYING SPONSORS LOGOS AT ALL MULTI-SPORT RACES, CEREMONIES, AND WHEN POSSIBLE OR REQUESTED, AT OTHER COMPETITIONS (RUNNING, BIKING, SNOWSHOE, ETC.). ALSO, ATHLETE WILL WEAR SPONSOR'S LOGOS WHEN POSSIBLE OR REQUESTED IN-GROUP TRAINING SESSIONS.

THE ATHLETE WILL BE REASONABLY AVAILABLE FOR INTERVIEWS, PHOTOS AND OTHER TEAM ACTIVITIES IN SUPPORT OF TEAM SPONSORS.

THE ATHLETE WILL ALWAYS PRESENT A POSITIVE, SPORTSMANLIKE IMAGE, BENEFICIAL TO THE SPORT AS WELL AS TEAM SPONSORS. HARASSMENT OF ATHLETES, VOLUNTEERS, CLUB STAFF OR OTHERS; AS WELL AS CHEATING AND OTHER UNSPORTSMANLIKE CONDUCT WILL NOT BE TOLERATED.

THE ATHLETE IS ENCOURAGED TO PARTICIPATE IN TEAM SPONSORED EVENTS (WORKOUTS, RACES, PARTIES, MEETINGS, ETC) UNLESS INJURIES, WORK, FAMILY OR SOCIAL OBLIGATIONS DESTINE OTHERWISE.

THE ATHLETE FURTHER ACKNOWLEDGES THAT MULTI - SPORT TRAINING IS AN EXTREME TEST OF PHYSICAL AND MENTAL LIMITS AND CARRIES WITH IT THE POTENTIAL FOR SERIOUS INJURY, DEATH, AND PROPERTY LOSS. *THE ATHLETE* ASSUMES THESE RISKS AND CERTIFIES THAT HE/SHE IS PHYSICALLY FIT AND HAS NOT BEEN ADVISED OTHERWISE BY A QUALIFIED MEDICAL PERSON.

IN RETURN FOR PARTICIPATING IN AND RECEIVING TEAM BENEFITS, THE ATHLETE AGREES TO TAKE ACTION FOR HIM / HERSELF, EXECUTORS, ADMINISTRATORS, HEIRS, NEXT OF KIN, SUCCESSORS AND ASSIGNS AS FOLLOWS:

WAIVE, RELEASE, DISCHARGE AND AGREE NOT TO SUE, FROM ANY AND ALL LIABILITY FOR ATHLETE'S DEATH, DISABILITY, PERSONAL INJURY, PROPERTY DAMAGE, THEFT OR ACTION OF ANY KIND WHICH MAY HEREAFTER ACCRUE TO ME AS A RESULT OF MY PARTICIPATION IN OR TRAVELING TO OR FROM ANY WORKOUT OR EVENT.

THE FOLLOWING PERSONS OR ENTITIES, SPONSORS, REPRESENTATIVES OR AGENTS OF SPONSORS, TEAM DIRECTORS, TEAM MANAGERS, TEAM COACHES, EVENT PRODUCERS OR MANAGERS, ALL CITIES OR STATES AND THEIR OFFICERS, DIRECTORS AND EMPLOYEES.
